1.) INTRODUCTION

Liberia's economic and social development is largely dependent on the agricultural sector and more so, because about 70 percent of the population livelihood is also dependent on it; a recognition given by the Comprehensive African Agricultural Development Programme (CAADP), the continent-wide framework that seeks to restore agricultural growth, facilitate rural development, and ensure food and nutrition security in Africa, of which Liberia is signatory. The dominant form of farming in Liberia is subsistence in nature and is characterized by shifting cultivation (slash and burn) and the use of low inputs, hence low yield.

In an effort to improve and increase agricultural outputs, the Government of Liberia established the Department of Agriculture, now Ministry of Agriculture (MOA), in 1948, which subsequently created the Bureau (now Department) of Regional Development, Research and Extension in 1960 with the mandate to transmit agricultural technology through training and disseminating useful and practical information to farmers. The extension method used was primarily on a technician-to-farmer or "training and visit" basis. However, effective and efficient agricultural extension and advisory services, which are critically important for smallholder farmers, in particular women and youth, has been grossly inadequate due largely to low capacity, poor coordination and lack of a policy framework for extension itself.

In July 2012, the MOA, through the Department of Regional Development, Research and Extension (DRDRE), with technical support from USAID, completed its first "National Policy for Agricultural Extension and Advisory Services" (NPAEAS). The NPAEAS, in its current form, will, upon legislation, serve as the *legal and enabling framework* for extension service delivery in the country. Besides, it will serve to enhance and support CAADP's pillar 4: "strengthening agricultural research, technology dissemination, and adoption" and by that means also boost efforts initiated by the continental body, the African Forum for Agricultural Advisory Services (AFAAS). In 2011, Liberia was invited and participated in its first major engagements with AFAAS and the Global Forum for Rural Advisory Services (GFRAS) in Ghana and Kenya respectively. This was followed in August 2013 with participation in the "Agricultural Extension Week and General Assembly" meeting in Gaborone, Botswana.

Against this background, a National Stakeholder Meeting on Agricultural Extension and Advisory Services (AEAS) Providers was organized by the Department of Regional Development, Research and Extension (DRDRE), Ministry of Agriculture, under the auspices of the African Forum for Agricultural Advisory Services (AFAAS) in Gardnersville, Liberia on Thursday, July 3, 2014. The welcome remark was done by Hon. Thomas Gbokie, Jr., Deputy Minister, DRDRE while the keynote statement and official opening of the meeting was done on behalf of the Minister of Agriculture, Dr. Florence Chenoweth, by Dr. Charles McClain, Deputy Minister of Planning and Development. This was followed by remarks from AFAAS Executive Director, Dr. Silim M. Nahdy and power-point presentations. The technical sessions included group task work and presentations as well as plenary discussion of group task work. The group task work was composed of four groups-**Group 1**: a) *Expected added value of CF to stakeholders*; b) *Main objectives of the CF*; **Group2**: a) *Representation of various stakeholders in the CF* b) *Roles & responsibilities of different participants* c) How will the CF be hosted?; **Group 3**: a) How will CF/activities be financed? b) *Legal status of the CF*; Group 4: a) *who are the important partners/alliances to the CF*? b) *Who will lead the* CF? c) *What is the requisite skills/knowledge needed in the CF*? d) *How to accomplish these*?

The group discussions were facilitated by experts drawn from both policy and technical institutions, including the Ministry of Agriculture and AFAAS Secretariat.

This report, which is the outcome of the July 3, 2014 meeting, is arranged into 4 sections: Introduction; Conceptual Framework; Highlights of Key Issues Discussed, based on comments/inputs made by participants held at different stages of the meeting, as well as Conclusions, Recommendations and Way Forward as proposed during plenary discussion and closing remarks.

Over 70 participants attended the 1 day meeting representing farmers, public, private, and UNAgencies as well as the NGOs community.

Welcome remarks

In welcome remarks, Hon. Thomas Gbokie Jr., Deputy Minister for the Department of Regional Development, Research and Extension welcome everyone to the stakeholders meeting on Agricultural Extension and Advisory Services (AEAS) and acknowledged the presence of guests from AFAAS Headquarters in Kampala, Uganda, in persons of Dr Silim M. Nahdy, Executive Director and Mr. Max Olupot, Technical Assistant. Having these guest of honour is a boost in the way forward on how we can build our agriculture extension service delivery especially for the establishment of the Country Forum which will be a platform that we think and hope will bring together all of the stakeholders in the sector. He lauded the efforts of the AFAAS team for their technical support to Liberia as the country moves toward the establishment of its country forum (CF) and become a full-fledge member of AFAAS at the soonest possible time.

Deputy Minister Gbokie noted further that agriculture remain the main stake of Liberia's economy and as such over 60% of the country's rural population is engaged in the sector. By that means, agriculture extension and advisory service plays a critical role in addressing the needs of Liberian farmers. Therefore the ministry places very high premium on agriculture at this time of our nation's rebuilding process. "We will make sure that we provide effective and efficient extension services to our farmers", Minister Gbokie concluded.

a. **Keynote Statement:** Dr. Charles McClain, Deputy Minister for Planning and Development of the Ministry of Agriculture delivered the keynote statement on behalf of Dr. Florence A. Chenoweth, Minister of Agriculture of Liberia.

In his remark, Dr. McClain noted that the Minister attaches great importance to the establishment of Liberia's Country Forum as it will be a platform that will bring all the stakeholders together in the decision and policy making for agricultural extension service delivery in the country. Adding that all over the world, in all of the international organizations, agricultural extension service delivery is coming up as "what I may consider a new paradigm shift". We can now see or have the involvement of the farmers in the decision making of policies that would affect their lives, and the Ministry of Agriculture of Liberia is proud that in this meeting or forum, we have farmers represented to have their say in whatever will be carved as a national organization, noting that the Ministry of Agriculture attaches serious importance to this meeting. Dr McClain further observed that agriculture extension under the leadership of the Department of Regional Development, Research and Extension (DRDRE) may be seen as the driver of this forum but "let it be known that it is the entire ministry that is in this". I am glad he said, that since the farmers are here today, their voices will be heard in the formulation of the agriculture extension service delivery; this means that whatever we do at research will be transferred to the farmers through extension service delivery, thus achieving our objectives under transformation. The Deputy Minister further indicated that "as focal person for CAADP, I am particularly happy to know that from the planning and development point of view, this platform will go a long way in revitalizing and reinvigorating that which CAADP needs to do over the next decade". As we go into the 2015 post development agenda, we in Africa will be speaking with one voice, and this course has now become Africa's position. And our president, Her Excellency Madam Ellen Johnson-Sirleaf, chairperson of this high level forum, who will be going to make her presentation at the United Nations General Assembly on post development agenda, CAADP will play a major role in her deliberation in terms of continental development of our agricultural sector, Dr. McClain further observed.

We want to thank Dr. Moses Zinnah, the Director of the Programme Management Unit (PMU) who is driving all of the Ministry's projects. This PMU is the unit that is housing seven of the projects that is also providing agriculture extension service delivery to our smallholder farmers. In closing, I would like to add that as we are here finalizing plans for the revitalization of our Central Agriculture Research Institute (CARI), you can see that it is a coincidence of plans and it is our prayer that all this will set the pace for igniting our agriculture sector.

Dr. McClain later officially declared the "National Stakeholders Meeting on Agricultural Extension and Advisory Services (AEAS) Providers" opened for deliberations.

Other Remarks:

Dr. Silim M. Nahdy-AFAAS Executive Director: Speaking earlier, AFAAS Executive Director Dr. Silim M. Nahdy said he was very happy to be part of this important meeting for this is what he had long waited for noting that AFAAS serves as a platform that is leading extension into two main dimensions: Professionalism and Methodology.

On professionalism, the Executive Director said the farmer who is to get a way of acquiring sufficient food must be made professional. Beside the farmer, all the players must be made professional people if we are to succeed in our work and activities.

On Methodology, he said it was time to collectively improve farmers' method of farming in order to give substance to machinery farming; and AFAAS is preparing all it member country to this level. This, he said, will bring on board value chain addition, capacity building, and formation of a full-fledge organization. This, he added will show who is who, who is doing what, the role of the farmer, the private sector, public sector, with whom to share the lessons learnt. Stressing that he had come to Liberia to show how Liberia can be a part of the AFAAS Organization. He noted that AFAAS is about bringing all stakeholders on board including farmers, farmer organizations, public and private sectors, international and local NGOs, research and higher institutions of learning, including all agricultural training programs. Dr. Nahdy added further that "it is not as hard as we may think, because other countries like Uganda, Ethiopia, Botswana, and Ghana have used the same method and succeeded. All you have to do is to make sure all stakeholders are a part of the process". Concerning the leadership, the Executive Director said that Ghana used the Director of Extension as focus person. Other used the private sector, while Ethiopia used someone from the University as chairperson. Just do it legally to make seeking of funding easy he added. Speaking further, he mentioned that AFAAS is a Global forum around the world and when established in any African country would always be supported if there is a better linkage amongst AFAAS member countries as to improve the farmer livelihood.

In closing, Dr. Silim said, "With what I am seeing in this hall today I am convinced that this meeting will yield a fruitful result".

Dr. Moses Zinnah/ Director PMU-MOA: Also speaking at the opening of the forum, Dr. Moses Zinnah, Director, Program Management Unit of the Ministry of Agriculture, noted that the advisory system will be one that is pluralistic noting that government, private sectors, farmers associations and others will be central in providing services to farmers. He added by saying that "it is a good thing for us to build on a system, and I think this is one outcome ofour extension policy and as it is said, it is in consonance with the CAADP process under pillar IV in the dissemination of research coupled with our own LASIP pillar I and III in terms of food security and institutional capacity building which are clearly stated in our strategic plan for the sector". Noting that "It is good that we are here to plan it today because we want to insure that whoever will come from AFAAS will know that the country is serious, because they will not only see people from the Ministry of Agriculture, but will also see farmers as well as other people meaningful to the sector".

He applauded Deputy Minister Gbokie and Director Perry for their tireless efforts and encouraged all of the stakeholders to work along with them so as to have a good setting for the establishment of the country forum, Dr. Zinnah concluded.

2.) CONCEPTUAL FRAMEWORK:

Background

The Africa Forum for Agricultural Advisory Services (AFAAS), a Sub-Saharan African Network on Agricultural Advisory Services (SSANAAS) initiated in Kampala, Uganda in 2004, has the mandate to implement the agriculture services aspects of CAADP. Working along with the Forum for Agricultural Research in Africa (FARA), AFAAS aims to actualize CAADP Pillar IV by strengthening engagement between research and extension as a way of effecting support to African farmers, by sharing agricultural knowledge and information, including research results.

It is to be noted that the efforts of AFAAS-CAADP Pillar IV are in line with the Government of Liberia's Poverty Reduction Strategy (PRS), especially Pillar II: Economic Revitalization which is aimed at improving and increasing agricultural productivity, restoring value chain and market access, strengthening agricultural institutions and providing greater agricultural opportunities for small-holder farmers. It is also a means of transforming the agriculture sector and improving the economy, especially in the realization that agriculturehas the *highest potential of sustainable employment creation* than any other sector; it is the livelihood of the majority of Liberians.

In 2011, Liberia was invited and participated for the first time in an AFAAS conference, under the theme "*Going Beyond Production Agriculture for Smallholder Farmers*", *which was*held in Accra, Ghana from April 12-14, 2011 under the auspices of FARA. This was followed by another invitation in November of the same year to participate in the 2nd annual meeting of the Global Forum for Rural Advisory Services (GFRAS) and the international conference on "Innovations in Extension and Advisory Services" which were held in Nairobi, Kenya from November 13-18, 2011. This landmark meeting culminated in the famous "Nairobi Declaration on Agricultural Extension and Advisory Services", which recognizes inter alia:

- 1. That smallholder agriculture and family farming is the core contributor to agricultural production in most developing countries, and therefore vital for achieving food and nutritional security and for dealing with climate change;
- 2. That efficient agricultural extension and advisory services support innovation and strengthen capabilities of smallholder farmers to access realistic and remunerative opportunities through knowledge, credit, markets and related services;
- 3. That a coalition of public, private and civil society actors at national, regional and international levels is needed to revitalize and strengthen agricultural extension and advisory systems;
- 4. That extension plays an indispensible role as facilitator, knowledge broker and matchmaker between service and support providers on the one hand and smallholder entrepreneurs on the other. Extension has the lead responsibility for ensuring that multiple stakeholders coordinate and integrate into adaptive innovation systems.

Participants at that Nairobi meeting therefore requested the conference organizers to continue to provide the platforms at different levels for extension professionals and researchers and farmers to meet, to exchange and improve their capacity to mobilize smallholders' knowledge, labour, land, water and genetic resources for global food security. *Again in August 2013 Liberia was invited and participated in the* four-day "**Agricultural Extension Week and General Assembly**" conference organized by the African Forum for Agricultural Advisory Services (AFAAS), in collaboration with the Ministry of Agriculture, Botswana, and the Botswana College of Agriculture (BCA), under the theme: "**Value Chain Approach in Agricultural Development: Coping with New Demands for Advisory Services**", which was held in Gaborone from August 5-8, 2013.

Liberia, through the Ministry of Agriculture, has been represented at these conferences by Dr. Moses M. Zinnah and Edward B. Perry both of the MOA. However, additional representation from Liberia is possible, especially with the establishment of Liberia's country forum (CF). The organization of Liberia-CF would therefore create the enabling environment for future engagement and participation by Liberia in all AFAAS activities as well as that of the global organization the "Global Forum for Rural Advisory Services" (GFRAS). It is hoped this can be realized before the next AFAAS meeting scheduled for Ethiopia in 2015.

Purpose, Objectives and Expected Outcome of July 3, 2014 Meeting:

With headquarters in Kampala, Uganda, AFAAS works with a network of Country Fora in carrying out its activities on the continent. Hence the foundation for AFAAS is a network of CF, such as the one being proposed for Liberia. Membership to AFAAS is almost automatic, but only through an established country forum. Therefore the general objectives are to:

- 1. Create awareness about AFAAS and GFRAS in Liberia;
- 2. Create stakeholders interest in AFAAS and GFRAS;
- 3. Identify lead actors in the provision of AEAS in Liberia;
- 4. Get stakeholders involved in establishing AAS and identify entry points and lead actors for setting up CF;
- 5. Propose the establishment of an "AEAS Working Group" under the ACC that would serve as a platform for establishing Liberia CF
- 6. Establish Liberia "country forum".

The meeting specific objectives are to:

- 1. Organize AEAS Technical Working Group under the aegis of the Agricultural Coordinating Committee (ACC) Meeting;
- 2. Establish Liberia-AFAAS Country Forum.

Outcome:

- AEAS actors brought together under one umbrella;
- Information exchanged, lessons and experiences shared;
- Opportunities for providing services to each other identified;
- AEAS Technical Working Group organized within the ACC;
- Liberia-AFAAS Country Forum initiated and established;
- Link established between Liberia CF and AFAAS on the one hand and AEAS stakeholders and AFAAS on the other;
- Forum provided for networking among AEAS actors in Liberia.

3.) HIGHLIGHTS OF KEY ISSUES DISCUSSED

The following highlights and analysis from the "National Stakeholders Meetingon Agricultural Extension and Advisory Services (AEAS) Providers", under the auspices of the "African Forum for Agricultural Advisory Services" (AFAAS), border on issues emanating from remarks, presentations as well as from discussions at various levels of the 1 day forum. Some of the issues highlighted appertain

to the proposal for the establishment of the "Liberia Forum for Agricultural Advisory Services (LIFAAS), including its mission, vision; objectives; stakeholder representation, including their roles and responsibilities; financial and legal implications; who are important partners/alliance as well asstructure and leadership of the proposed Country Forum (CF).

Following various remarks, presentation and a question and answer period, four (4) working groups were set up and tasked with discussing the issues relevant to the forum as reflected in the table below:

CONCLUSION Closing Statement:

- **Dr. Silim M. Nahdy,** in his closing remarks thanked the organizers of the stakeholders meeting for a successful time together, adding that he was not closing the meeting, but rather he was opening the way for Liberia entry into AFAAS. "There are challenges out there and that you should be able to tap on the expertise of consultants at AFAAS headquarters, and that we can say go to Liberia and see what assistance can be rendered there so that the Liberian chapter can grow", he concluded.
- Honourable Fofi Bianba, Member, House of Representatives and co-chair on Agriculture, thanked the organizers as well as the guest from AFAAS for their contribution and effort in encouraging Liberia's participation in the Africa Forum for Agricultural Advisory Services. He added that if those in parliament were all agriculturist, they would have seen the 10% allotment to agriculture as a means to development in the agriculture sector. "It pains my heart to see Liberia importing tomatoes from an arid country such as Mali, when we have such fertile soil. If our leadership were agriculture oriented, they would have had passion to ensuring the promotion of agriculture". Comparing Liberia and Bangladesh, he said the two countries are of the same land mass but different population. Bangladesh has about 145 million people as compare to Liberia, but yet they still export what we call our staple rice to us. I am pleased that the Ministry of Agriculture has the right governing team, and now they can turn the wheels. Therefore we should not cease talking. If we continue, they will listen to us", Representative Baimba concluded.
- **Dr. Silim M. Nahdy:** Reacting to Representative Baimba's remarks, AFAAS Executive Director, Dr. Nahdy said that this was one of the most important speeches he had heard so far; noting that Ethiopia and Rwanda have gone through war, but they put about 20% of their national resources into agriculture. Job creation can be with the sector provided if we can put our resources into agriculture. It can now be seen that Ethiopia is expanding in agriculture because she has put her resources into agriculture for that is where their mouth is, the Executive director concluded.
- **Minister Gbokie** in his closing thanked the stakeholders for coming and for the job well done. Noting it was useful having completed the meeting. As we have learned from other countries, it is my hope that we can adopt so that Liberia can be recognize at the international platform. I am also happy that we have had a nine member committee who will steer the affairs of the country forum.

We did not make a mistake by saying that extension is the driving force in advisory services delivery. We are glad that the team from our international friends came and that we shall make sure all that were said is enacted. We will work with all our partners and make sure their expertise is employed. I am also glad that the issue of the youth was mentioned and that we should consider it very seriously. Thank you and have a bless day.

With that final remark, the one day "National stakeholders meeting on Agricultural Advisory Services (AEAS) Providers" came to a successful close.

At the end of presentations all 4 groups and the plenary session, Dr. Moses M. Zinnahrecommended the setting up of an "**Interim Steering Committee**" (ISC) to steer the affairs of the Country Forum. He therefore suggested that individuals at the meeting should volunteer to serve in the capacity as ISC Member.

Following the suggestion by Dr. Zinnah, nine (9) persons volunteered/were recommended to form part of the ISC. They include:
