Title: Construction of DAO Offices in Nimba County *Ref #:* MOA/PMU/IFAD/TCEP/NCB/WC-07/2020-2021

- 1. The *Government of Liberia* has received (or in appropriate cases "has applied for") financing from the International Fund for Agricultural Development (IFAD) and intends to apply a part of the proceeds to the financing of this procurement. The use of any IFAD financing shall be subject to IFAD's approval, pursuant to the terms and conditions of the financing agreement, as well as IFAD's rules, policies and procedures. IFAD and its officials, agents and employees shall be held harmless from and against all suits, proceedings, claims, demands, losses and liability of any kind or nature brought by any party in connection with *Tree Crops Extension Project-I*.
- 2. TCEP-I includes an IFAD loan of US\$ 13 million and an Adaptation for Smallholder Agriculture Programme (ASAP) grant of US\$ 4.5 million. The project will work towards developing a viable and sustainable smallholder cocoa sub-sector in Liberia's main producing belt.
- 3. This IFB follows the General Procurement Notice that appeared on the IFAD website on *January 5, 2021*, the Executive Mansion and the Ministry of Agriculture website on *January 5, 2021*, and a national newspaper *inprofile daily* on *January 5, 2021*.
- 4. The employer now invites sealed bids from eligible entities ("bidders") for the execution and completion of *Construction of four (4) DAO Offices in Nimba County*, which are being bid as a unit price contract based on the bill of quantities.¹
- 5. This IFB is open to all eligible bidders who wish to participate. Subject to the restrictions stipulated in the bidding document, eligible bidders may associate with other bidders to enhance their capacity to successfully carry out the works.

6. The works, and the contract/s expected to be awarded, are divided into the following lots:
