Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on 16th October 2023 at 1400 hours.
- 7. All Bids must be accompanied by a Bid-Securing Declaration. The Bidder shall fill in the Bid Securing Declaration Form in Section IV. The number of years is (Two (2) years or 24 months from and said Bid Securing Declaration shall be notarized which binds each bidder to the process from end to start of the specified bid validity period so that Client can be guaranteed of total commitment of the successful bidder of not withdrawing from the process, after been notified, to signing of contract, and subsequent supply of goods.
