The Government of Liberia is implementing a grant from the Global Agriculture and Food Security Program (GAFSP) and a loan from the African Development Fund toward reducing rural poverty and household food insecurity by increasing income for smallholder farmers and rural entrepreneurs particularly women, youths and the physically challenged. The Government of Liberia intends to apply part of the proceeds to payments under the Contract for the **Supply of Assorted Laboratory Apparatus with Contract No: LIB/SAPEC/PMU/GC/NCB/001/2017 in one complete Lot.**
- 1. The Program Management Unit (PMU) of the Ministry of Agriculture now invites sealed bids from eligible and qualified bidders for the **Supply of Assorted Laboratory Apparatus** as indicated below:
